










## LIABILITY, INJURY AND PROPERTY DAMAGE WITH AUTHORIZATION FOR MEDICAL TREATMENT



If the athlete registering herein has any pre-existing health-related medical conditions, allergies, diseases, etc. that could potentially prohibit, prevent or limit him/her from participating in events such as this, please advice us of them in the space provided below:

In addition, I hereby release, waive, indemnify, save, forever discharge and agree not to sue any of the other participants or staff of MexGames 2016, as well as Collegiate Sports of America, National Commission of Physical Culture and Sports of México; the Institute for Mexicans Abroad, Mexican Consulates in the United States; the Institute of Sports in the Morelos State; Long Beach Sports Arena, The Performing Arts Center, Hotel Westin Long Beach, Bell Gardens Sports Complex, The Long Beach Hilton, Renaissance Hotel, The City of Long Beach, and any or all of their employees, officers, contractors, subcontractors, partners, sponsors, agents, affiliates, volunteers or assigns from all present or future claims that may be made by either the participating athlete or me, my family, estate, heirs or assigns for property damage, theft, personal injury, bodily harm, wrongful death or any other potential liability arising as a result of participation in the MexGames 2016 (and possibly caused by the ordinary negligence of the parties listed above, wherever, whenever, or however same may occur).

I grant permission and authorization for my athlete to receive first aid or medical treatment as needed and, to the same extent and scope as previously mentioned, I also agree to release (indemnify and hold harmless) said parties from any and all claims whatsoever which may be attributable to the receipt of said treatment rendered in connection with (and/or arising out of participation in) such event.

I affirmatively swear that I am the parent or legal guardian of the previously named participating athlete and do hereby execute this liability release and waiver on behalf of that individual. I agree that the terms of this release are binding on my athlete and me.













## LIABILITY, INJURY AND PROPERTY DAMAGE WITH AUTHORIZATION FOR MEDICAL TREATMENT

I am of legal age and am freely and voluntarily signing this document without inducement from any party.

In addition, I understand that engaging in any sport or physical activity includes the inherent and substantial risk of personal injury or property damage. With respect to same, I voluntarily grant permission and authorization for my athlete to participate in the MexGames 2016 and agree to assume the complete risk of and responsibility for any injury or damage that may result from (or be related to) his/her participation.

I also grant permission and authorization to the physicians, athletic trainers and medical consultants of the MexGames 2016 to evaluate and treat any injuries that may occur during my athlete's participation in it. In addition, I understand that they have the authority to prohibit or eliminate my student-athlete from participation (because of either an injury or any risk of liability to anyone associated with this event).

I further represent that I have read and fully understand this document and, by signing it, am giving up legal rights and remedies.
